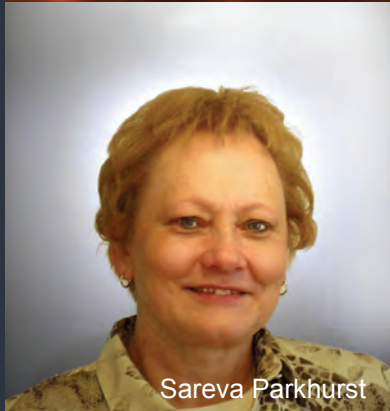

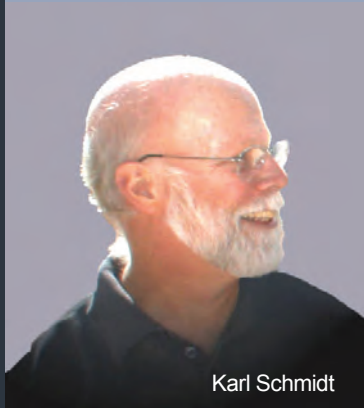

She had been previously living in a motel with her one year old daughter.
